Chapter 1 Rear Panel Interfaces

Description

The rear panel interfaces vary with different models. Refer to Table 1-1 for the common interfaces description of rear panels.

Chapter 2 Installation and Connections

2.1 NVR Installation

During installation of the NVR:

- Use brackets for rack mounting.
- Ensure ample room for audio and video cables.
- When routing cables, ensure the bend radius of the cables are no less than five times of its diameter.
- Allow at least 2 cm (≈ 0.75 inch) of space among racks mounted devices.
- Ensure the NVR is grounded.
- Environmental temperature should be within the range of -10°C to 55°C (14°F to 131°F).
- Environmental humidity should be within the range of 10% to 90%.

2.2 HDD Installation

For NVR that has not been pre-installed HDD, it requires to install HDD for storage.

Before you start

- Ensure power is disconnected.
- Prepare a factory recommended HDD, and cross screwdriver.

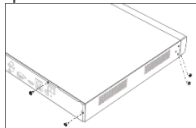


Figure 2-1 Remove Cover

Step 1 Unfasten screws on each panel to remove the device cover. Refer to Figure 2-1.

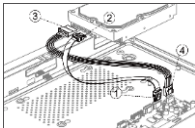


Figure 2-2 Connect Cable

Step 2 Connect the data cable and power cable. Refer to Figure 2-2.

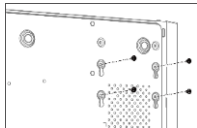


Figure 2-3 Fix HDD

Step 3 Match HDD screw threads with the reserved holes on the device bottom, and fix HDD with screws. Refer to Figure 2-3.



NOTE

You can repeat the steps above to install other HDDs.

Step 4 Reinstall the device cover and fasten screws.

Chapter 3 Menu Operation

3.1 Startup

Proper startup is crucial to expand the life of NVR. It is HIGHLY recommended to use an Uninterruptible Power Supply (UPS) with the device.

Step 1 Plug power supply into an electrical outlet.

Step 2 Press the power button (certain models may have power button on the front or rear panel). The device begins to start.

3.2 Activate Your Device

No operation is allowed before activation. For the first-time access, it requires to set an admin password for device activation. You can also activate the device via web browser, SADP or client software.

Step 1 Enter the same password in **Password** and **Confirm Password**.

Step 2 Enter the **Camera Activation Password** or click **Use the Device Password** to use the device password to activate the camera(s) connected to the device.

Step 3 Click **Activate** to save the password and activate the device.

3.3 Set Unlock Pattern

For the Admin user, you can configure the unlock pattern for device login.

Step 1 Use mouse to draw a pattern among the 9 dots on the screen. Release the mouse when the pattern is done.

 **NOTE**

- The pattern shall have 4 dots at least.
- Each dot can be connected for once only.


Step 2 Draw the same pattern again to confirm it.

3.4 User Logout, Shutdown and Reboot

You can log out of the system, shut down, or reboot the device.

Step 1 Click  on the upper-right corner.

Step 2 Click **Logout**, **Shutdown**, or **Reboot** as your desire.

3.5 Network Settings

You shall properly configure the network settings before you operate NVR over network.

Step 1 Go to **Configuration > Network > General**.

Step 2 Set the network general parameters.

Step 3 Click **Apply** to save the settings.

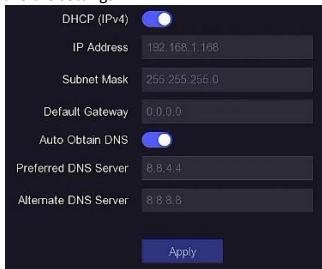


Figure 3-3 Network Settings

3.6 Add IP Cameras

Before you can get live video or record the video files, you should add network cameras to the device.

Before you start

Ensure the network connection is valid and correct, and the IP camera to add has already been activated. Please refer to the *User Manual* for activating the inactive IP camera.

Step 1 Go to **Camera > IP Camera**.

Step 2 Click **Custom Add**.

Step 3 Enter IP address, protocol, management port, and other information of the IP camera.

Step 4 Click **Add**.

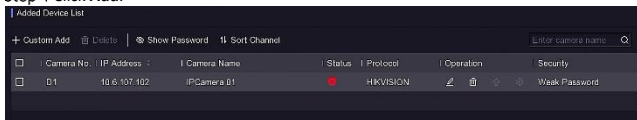



Figure 3-4 Add IP Camera





3.7 Live View and Record Settings

Live view shows you the video image getting from each camera in real time. The NVR will automatically enter Live View mode when powered on. In the live view mode, there are icons at the right top of the screen to indicate the status of record and alarm for each channel. You can click  at the toolbar to start recording.

Live View Icons

In the live view mode, there are icons on the screen to indicate the record and alarm status of each channel.

3.8 Playback

The recorded video files and pictures on HDD can be played back. Refer to the user manual for details of each playback mode.

Step 1 Go to **Playback**.

Step 2 Check the channel(s) in the channel list.

Step 3 Double click a date on the calendar.

Step 4 (Optional) Use the toolbar in the bottom to control the playing progress.

Chapter 4 Accessing by Web Browser

You can get access to the device via web browser. You may use one of the following listed web browsers: Internet Explorer 6.0 and above, Apple Safari, Mozilla Firefox, and Google Chrome. The supported resolutions include 1024*768 and above.

Step 1 Open web browser, enter the IP address of the device and then press **Enter**.

Step 2 Log in to the device.

- If the device has not been activated, activate the device first by setting the password for the admin user account.
